Therefore, as a condition to maintaining its DSI franchise rights, our league hereby indemnifies and holds harmless DSI and its officers, directors, state and district officials, and administrative employees, (collectively the "releasees"), for any legal action, including a reasonable attorney fees, based on child abuse/molestation allegations including any allegation of negligence on the part of any or all of the releasees, arising from any teams, leagues, tournaments, or other activities of our league."
